The Township's financial responsibility is \$2,934.00. Mr. Dole seconded the motion, roll call - all yea.

Mr. Losekamp reported that we have been contacted regarding the next round of funding through the Community Development Block Grant Program. The Trustees agreed that we have no projects at this time.

Mr. Losekamp reported that he submitted an invoice to the Hamilton County Engineer's Office for reimbursement for work done on Farmland Drive this summer. The Township will be reimbursed through the Township's 20% allocation from the County portion of the 2nd \$5.00 Permissive License Tax.

Mr. Dole reported that the tree on Flintwood Drive, which was causing a safety issue, will be removed by Cincinnati Tree Care.

Mr. Dole reported that Mr. Dan Losekamp, will be probing all the lots owned by the Pigg family in Baptist Cemetery. The family is inquiring as to where the graves are so a headstone can be installed.
