Mr. Losekamp reported that the Trustees received the 2016 Bridge Inspection Report, provided by the Hamilton County Engineer, and were asked to comment if there were any questions or corrections.

Mr. Losekamp reported that Attorney, Elizabeth M. Stanton, will be retiring from Taft at the end of 2016 and her firm will not be sending to us a Retainer Agreement and Resolution for the upcoming year.

Mr. Losekamp reported that Unilock (the company considering locating into the Harrison Commerce Center), has applied for a variance to change zoning to GG Industrial. The hearing will be on December 15, 2016 before the Hamilton County Board of Zoning Appeals.
