Mr. Dole reported that we will wait til Spring to do a thorough review of properties in our township.

BUSINESS REPORT

Mr. Noes made a motion to approve the mowing contracts with Pro Active Services, Inc. for 2016 at the Baptist Cemetery, Woodlawn Cemetery and the I-74 at Dry Fork Road entrance and exit ramps. Mr. Dole seconded the motion, roll call - all yea.

Mr. Dole made a motion to approve the Township's contribution to the JEDD Board to cover the administrative costs in 2016 in the amount of \$4,000.00. Mr. Noes seconded the motion, roll call - all yea.

Mr. Losekamp reported that he contacted Southern Ohio Door Controls, Inc. to furnish and install one Tucker Single Door Operator with two radio controlled pushplates at the cost of \$2564.00 at the Township Civic Center.

Trustees reminded everyone that the Roadside Clean-up will be on Saturday, April 30th, 2016. The document shredding will be available from 10:00 a.m. - 2:00 p.m.

Mr. Losekamp reported that the Township received the Annual Mileage Report from the Hamilton County Engineer's Office.

It was reported that the Township recently purchased a 2006 GMC truck from Whitewater Motors, Inc. to be used for our snow plow. Cost of the truck plus the items needed to convert it to a snow plow will be approximately \$55,000.00. If a new truck was purchased, it would have been approximately \$140,000.00.

Mr. Dole reported the he talked to the Mayor of the City of Harrison about the new I.D. cards that the City of Harrison employees will be carrying. The Mayor offered to provide I.D. cards for Township employees if we are interested. Mr. Dole will be in contact with the Mayor to set this up.




ADJOURNMENT
