Mr. Losekamp reported on the following items that were discussed at the last Building and Lands Committee meeting:

1. Discussion about constructing pickle ball courts next to the tennis courts in front of the Community Center Building; 2. Discussed the reconfiguration of the ball fields at the Community Center to provide centralized viewing of the games, concessions and restrooms. The City of Harrison Mayor is concerned that this might hamper the shooting off of fireworks; 3. Discussion of the construction of a water fountain near the walking trail in the approximate amount of \$2,800.00 with the Township paying half.

Mr. Losekamp reported that he received an email from Mr. Shannon Hamons, City of Harrison Economic Development Director, wanting to see if Harrison Township will partner with the City of Harrison to participate in the National Fitness Campaign. This program will privide 30 pieces of exercise equipment to be constructed on a 38 ft. x 38 ft. concrete pad. More information will be provided at a meeting on August 4, 2017 at 3:30 p.m.
