Mr. Noes made a motion to approve the Agreement between the City of Harrison and Harrison Township for the Provision of Comprehensive Fire and EMS/ALS Services for the period January 1, 2021 through December 31, 2030. The City shall furnish the township comprehensive fire, EMS and fire inspection services on a twenty-four hour, seven-day a week schedule in the same manner that such services are provided to the citizens of the city. Compensation, terms of payment and other details are included in the Agreement. Mr. Dole seconded the motion, roll call - all yea.
