The Certificate of Estimated Resources for 2018 was discussed and will be submitted to the County Auditor as prepared by the Fiscal Officer.

The Annual Appropriation Resolution for 2018 was reviewed and Mr. Dole moved for the adoption of this resolution. Mr. Noes seconded the motion, roll call - all yea.

Mr. Losekamp made a motion that Resolution 01-10-2018A Advance Payment of Tax Revenues be approved. Mr. Dole seconded the motion, roll call - all yea.

Mr. Losekamp made a motion that we establish the date, time and place for holding regular Board meetings as follows: third Wednesday at 7:30 p.m. at the Harrison Township Community Center Building, except for the May 2018, June 2018, July 2018 and August 2018 regular meetings which will be held at the Harrison Township Civic Center. Mr. Dole made a motion to establish a Records Commission composed of the President of the Township Board of Trustees and the Fiscal Officer of the Township. Mr. Noes seconded the motion, roll call - all yea.

Mr. Dole made a motion to approve the attendance and reimbursement of expenses for Township Officials at all state and national conferences, professional development conferences and meetings regarding township business during 2018. Mr. Noes seconded the motion, roll call - all yea.

Mr. Noes made a motion that funds shall be appropriated for the purpose of honoring or meeting with township employees, consultants, citizens, advisory groups, etc. The Board of Trustees does hereby affirm that the expenses associated with the items above do serve a public purpose for the promotion of local government, rapport with the business sector, community relations and encouragement of non-employees to participate in local government.
