The HarrisonrTownship Board of Trustees met in regular session with President Thomas C. Losekamp, calling the meeting to order. Answering the roll call were: Frederick A. Dole, William R. Noes and Thomas C. Losekamp.

FISCAL OFFICER'S REPORT

VISITORS

Mr. Brian Lammers, who is building a house on Harmony Drive, inquired about the possibility of sidewalks being installed on New Haven Road from the new St. John the Baptist Church to Circling Hills Golf Course. Mr. Losekamp responded that the Township would be in favor of this, but would need to work with the City of Harrison and Hamilton County in order to work out all the details and assess the cost benefits. Mr. Losekamp instructed Mr. Lammers to contact the Hamilton County Engineer's Office in the meantime.

Sergeant Jeremy DePaoli was present and distributed the following monthly reports: Hamilton County Communications Summary; Criminal Investigation Section; Uniform Incident and Traffic Crash.

Mr. Losekamp reported that he attended the Hamilton County Budget Hearing on November 13, 2018 and talked to Commissioner Todd Portune after the meeting. Mr. Portune acknowledged that Harrison Township cannot be without patrol of some kind. Sgt. DePaoli added that O.R.C. Chapter 29 requires some level of police patrol in unincorporated areas of each county.

Mr. Noes made a motion to approve the low bid from J.K. Meurer Corp, in the amount of \$58,909.00 for construction of the two pickle ball courts in front of the Harrison Community Center Building. Harrison Township will share the expenses of the construction of the pickle ball courts with the City of Harrison. Mr. Dole seconded the motion, roll call - all yea.

The Community Center parking lot resurfacing project began on November 13, 2018 and should be completed within two weeks.

Mr. Losekamp reported that the gas and water lines have been installed for the Unilock property on Southwest Parkway and they will be opening their office soon.

Mr. Losekamp reported that Duke Energy has requested that the gray water that Rumpke is dumping in a pipe on Southwest Parkway needs to be stopped.

Mr. Losekamp reported that the Farmland Drive street repairs will be delayed until Spring, 2019. In the meantime,
Mr. Loos was asked to fill in the major potholes on Farmland Dr.

Mr. Dole reported that we might need to look into a gas aggragation district.

Mr. Losekamp stated that he will be calling Rumpke and asking them to discontinue the recycling service effective December 1, 2018.
