Mr. Dole will contact Hamilton County again regarding the Kaeser Towing: property on Harrison Avenue because of old boats and a camper being stored there.

Mr. Dole reported that even though we continue to receive complaints regarding the trailer on the corner of New Biddinger Road and Carolina Trace Road, there is nothing we can do because they are in compliance with all Zoning and Board of Health rules and regulations.
