The Zoning Inspector informed Mr. Dole that the Housing Court might need to get involved regarding the old building on the hill behind Jefferson Street.

NUISANCE ABATEMENT REPORT

Mr. Dole reported we received a call from a resident about the property at 9013 Flintwood Drive. Apparently, the house has not been lived in for three years and the doors and windows have been boarded up. The Zoning Inspector said that he will look into having the property condemned and suggested we inform our legal counsel of this situation.

A complaint was also received about the property at 8971 Flintwood Drive regarding parking in the grass and junk scattered throughout the property. The Trustees will ask our legal counsel to send a nuisance letter to this property owner.

Mr. Dole reported that the property at 1110 New Biddinger Road continues to present problems. Only a portion of the yard is mowed, have not removed fallen limbs from their roof, have cardboard in place of a broken window and a part of the skirting has fallen off the mobile home. We may need to proceed with further punitive action on this property.

BUSINESS

Mr. John Loos, Road Supervisor, reported that the Township Spring Clean-up was a huge success. At least 20 dumpsters were used and the electronic and shredding companies were kept very busy with continual activity all day.

Mr. Losekamp and Mr. Dole discussed the possibility of building a new garage for Township maintenance vehicles and equipment at the Outpost. Dumpsters and fencing would have to be moved in order to create new space for employee parking.

Mr. Losekamp reported that at the last Building and Lands Committee meeting, the City approached the Township about a drainage problem on Biddle Avenue. The Trustees responded that while the Township did not do anything to create this problem and therefore are not in a position to remedy the problem.
