### OPENING

The Harrison Township Board of Trustees met in regular session with Chairman, Thomas C. Losekamp, calling the meeting to order. Answering the roll call were: Frederick A. Dole and Thomas C. Losekamp. William R. Noes was absent with notice.

### APPROVAL OF MINUTES

Mr. Dole made a motion to approve the minutes of the October 21, 2020 regular meeting. Mr. Losekamp seconded the motion, roll call - all yea.

### POLICE REPORT

Mr. Dole reported that there was an indigent burial in the Township recently and an invoice is forthcoming.



Mr. Losekamp seconded the motion, roll call – all yea.


### ADJOURNMENT
