MINUTES OF HARRISON TOWNSHIP BOARD TRUSTEES REGULAR MEETING

OPENING

The Harrison Township Board of Trustees met in regular session with Chairman, Thomas C. Losekamp, calling the meeting to order. Answering the roll call were: Frederick A. Dole, Mark A. Louis and Thomas C. Losekamp.

APPROVAL OF MINUTES

Mr. Louis made a motion to approve the minutes of the July 14, 2021 regular meeting. Mr. Dole seconded the motion, roll call - all yea.

FISCAL OFFICER'S REPORT

Mr. Louis made a motion to approve the Fiscal Officer's Financial Report, which includes the payment of the bills. Mr. Losekamp seconded the motion, roll call – all yea.

VISITORS

Bill Edge spoke regarding the proposed warehouse development along Simonson Road. He wanted an update on the annexation proposal announced by the City of Harrison and how it would affect the residential properties. Mr. Losekamp explained that the agreement had specific details outlining the protection of the resident's properties. Mr. Edge was concerned about the easement or right-of -way of one certain property and how the annexation would affect this easement.

POLICE REPORT

Sgt. Oliver Albert of the Hamilton County Sheriff's office reported that the month of July had some noteworthy incidents. A death investigation in the Whitewater River near 9110 Lawrenceburg Road, two theft reports, an auto theft, Psychiatric Emergency use of force, and disorderly conduct. There were 176 calls for service in Harrison Township. Deputies responded to 91 calls for service and logged out 85 calls for service due to be on the look of, public services, EMS runs etc. The average response time for service was 14 minutes which is up 2 minutes from last month. After the report from Sgt. Albert Mr. Dole questioned why 2 incidences were reported in Harrison Township when one was in Crosby Township and the other was in Whitewater Township. Sgt. Albert will make the correction.

FIRE REPORT

Mr. Louis reported the Township had 16 fire issues and 51 EMS calls in the Month of July.

ZONING REPORT

Mr. Dole reported that the County Zoning Inspector has been contacted to inspect a property on Lees Creek Road with some issues.

NUISANCE REPORT

Mr. Dole reported that grass on the property located at 10497 New Biddinger Road has been cut.

Mr. Dole still has concerns about the property at 11108 and 11110 New Biddinger Road Mr. Losekamp stated a sign will be installed soon.

BUSINESS REPORT

A discussion was held regarding a memorandum of understanding for an Intergovernmental Agreement for Economic Development with the City of Harrison

Mr. Louis made a motion to approve an Intergovernmental Agreement for Economic Development with the City of Harrison. Mr. Dole seconded the motion, roll call – all yea.

Mr. Louis made a motion to approve Resolution #81821A to accept the Intergovernmental Agreement for Economic Development with the City of Harrison. Mr. Dole seconded the motion, roll call – all yea.

Mr. Losekamp expressed concerns about the ownership of Cornerbrook Road. and the issues it may present in future development. After some discussion Mr. Losekamp will contact the attorney to figure out what options are available to solve the issue.

Discussion was held about the number of dumpsters to be used at the fall cleanup. Two tire dumpsters will available for use.

Mr. Losekamp stated that he had a discussion with Mayor Neyer from the City of Harrison to determine if the reinstallation of a gate at the Community Center near Etta Avenue is necessary. Further study will be necessary and a decision will be determined at a later date.

There was no correspondence.

ADJOURNMENT

Being no further business, Mr. Dole made a motion to adjourn the meeting. Mr. Louis seconded the motion, roll call - all yea. The meeting was adjourned at 8:25 p.m.
