OPENING

FISCAL OFFICER'S REPORT

VISITORS

Lisa Wynn resident of Brooks Road spoke in opposition of the proposed landfill expansion in Whitewater Township and ask the Harrison Township Board of Trustees to send a letter to the Hamilton County Commissioners to support the rules being considered for landfill regulation. The Board will make every effort to draft and send the letter before the Commissioners meeting.

Unilock Representative Bob Moser informed the board that the company located on Southwest Parkway is planning to expand and construct a 92K sq. ft. manufacturing plant on their current site and will comply with all Hamilton County zoning regulations. Mr. Moser stated that Unilock which is a family owned company is looking forward to being involved in the Harrison area.

Jill Schiller the new Hamilton County Treasurer introduced herself and explained the changes in the Treasurers office and will be available to answer any questions from the residents and Board of Trustees.

POLICE REPORT

Sgt. Oliver Albert of the Hamilton County Sheriff's office reported that there were a few noteworthy incidents in Harrison Township, there were several theft reports, burglaries, death investigation, sexual imposition and identity fraud. There were 7 auto crashes 3 with injury 4 with property damage. There were 144 calls for service in Harrison Township during this period. Deputies responded to 63 of those calls for service and logged out 81 calls for service due to Be on the Look Of, public services, EMS runs, etc. The average response time to responded calls for service was 13 minutes, which is up one minute from last month.
