OPENING

The Harrison Township Board of Trustees met in regular session with Chairman, Thomas C. Losekamp, calling the meeting to order. Answering the roll call were: Frederick A. Dole, Thomas C. Losekamp and Mark A. Louis

APPROVAL OF MINUTES

Mr. Louis made a motion to approve the minutes of the March 16, 2022 regular meeting. Mr. Dole seconded the motion, roll call – all yea.

FISCAL OFFICER'S REPORT

Mr. Dole made a motion to approve the Fiscal Officer's Financial Report, which includes the payment of the bills. Mr. Louis seconded the motion, roll call – all yea.

POLICE REPORT

Cpl. Justin Schaefer of the Hamilton County Sheriff's office reported that there were a few noteworthy incidents in Harrison Township. There were several theft reports in different areas of the township including a self-storage facility, domestic violence, violating a protection order, assault and criminal damaging. There were 4 auto crashes 3 with injuries 1 with property damage. There were 167 calls for service in Harrison Township during this period. Deputies responded to 93 of those calls for service and logged out 74 calls for service due to Be on the Look Of, public services, EMS runs, etc. The average response time to responded calls for service was 11 minutes, which is down 2 minutes from last month.

FIRE REPORT

Mr. Louis reported the Fire Department responded to 11 fire & rescue calls and 76 EMS runs in Harrison Township. The Harrison Fire Chief is seeing run volumes continue to increase. There will be a Damage Assessment Training held at the Harrison Township Civic Center on Friday June 24, 2022 from 9:00AM to 12:00 PM.

NUISANCE REPORT

Mr. Dole reported that the property located at 11440 Carolina Trace is being maintained and improving.

BUSINESS REPORT

Mr. Losekamp presented a proposal from Pavement Technology Inc. for sealing of Carolina Ridge Rd. Flora Rd. and Hopping Rd. to help extend the life of the roads. The cost would be \$15,105.18. Mr. Losekamp made a motion to approve the proposal from Pavement Technology Inc. Mr. Dole seconded the motion, roll call – all yea.

Mr. Losekamp informed the board that the Township needs a representative for the ICRC annual meeting. Due to conflicting meetings no one can attend this year. Mr. Louis will become the Township representative for future meetings and communications.

Richard Dole Fiscal Officer announced that the State Auditor's Office is conducting an audit on Harrison Township for the years 2020 and 2021. They should be finished by the end of April with a final report.

Mr. Losekamp announced the Township cleanup day will be on Saturday April 30, 2022 from 8:00am to 4:00pm. Paper shredding will be from 10:00am to 3:00pm. There will be a drug takeback event at the Harrison Township Civic Center from 10:00am to 2:00pm on the same day.

Mr. Losekamp announced that the Harrison Memorial Association will conduct a Memorial Day Parade and Ceremony on Monday May 30, 2022.
