#### POLICE REPORT

Sgt. Oliver Albert of the Hamilton County Sheriff's office reported that there were a few noteworthy incidents in Harrison Township. There were several theft reports in different areas of the township, violation of protection order, breaking and entering, a homicide and domestic violence. There were 6 auto crashes 1 with injury 4 with property damage and 1 deer strike. There were 128 calls for service in Harrison Township during this period. Deputies responded to 69 of those calls for service and logged out 59 calls for service due to Be on the Look Of, public services, EMS runs, etc. The average response time to responded calls for service was 13 minutes, which is up three minutes from last month. Sgt. Albert announced there will be a drug takeback event at the Harrison Township Civic Center on Saturday April 30, 2022 from 10:00am to 2:00pm.

#### FIRE REPORT

Mr. Louis reported the Fire Department responded to 11 fire & rescue calls and 45 EMS runs in Harrison Township. Mr. Louis reviewed all repairs completed on the Township fire truck and found they were needed for safe operation. The Fire Chief gave a list of supplies needed for the unit 56 township fire truck for compliance.
