## **MINUTES OF HARRISON TOWNSHIP BOARD TRUSTEES REGULAR MEETING**

### **OPENING**

The Harrison Township Board of Trustees met in regular session with Chairman, Thomas C. Losekamp, calling the meeting to order. Answering the roll call were: Frederick A. Dole, Thomas C. Losekamp and Mark A. Louis.

### **APPROVAL OF MINUTES**

Mr. Dole made a motion to approve the minutes of the October 19, 2022 regular meeting. Mr. Louis seconded the motion, roll call – all ye.

### **FISCAL OFFICER'S REPORT**

Mr. Louis made a motion to approve the Fiscal Officer's Financial Report, which includes the payment of the bills. Mr. Dole seconded the motion, roll call – all ye.

### **VISITORS**

Laura Hobson of Register Publications informed the board that Register Publications is consolidating four newspapers into one publication called the Register.

Doug Baer of Harrison Township advised the board that he was notified by the City of Harrison he will need to hook up to the new sewer line within the next five years. Mr. Baer was asking the board who he should talk to for an explanation of the necessity to hook up. The board encouraged him to contact the Hamilton County Board of Health for assistance in understanding the reason for hooking up.

Brad Johnson Director of the Hamilton County Environmental Services gave a report on the Hamilton County Solid Waste Plan Update. He explained how they provide recycling and waste reduction assistance to residents, communities, schools and businesses in Harrison Township and Hamilton County.

## **POLICE REPORT**

Sgt. Oliver Albert of the Hamilton County Sheriff's office reported that there were very few incidents in Harrison Township. There were 2 criminal cases for the month of October. There was a total of 3 auto crashes. There were 140 calls for service in Harrison Township during this period. Deputies responded to 73 of those calls for service and logged out 67 calls for service due to Be On the Look Of, public services, EMS etc. The average response time to responded calls for service was 11 minutes, which is the same last month.

## ADJOURNMENT


