### **OPENING**

The Harrison Township Board of Trustees met in regular session with Chairman, Thomas C. Losekamp, calling the meeting to order. Answering the roll call were: Frederick A. Dole, Thomas C. Losekamp and Mark A. Louis.

### **APPROVAL OF MINUTES**

Mr. Dole made a motion to approve the minutes of the September 21, 2022 regular meeting. Mr. Louis seconded the motion, roll call – all yea.

### **POLICE REPORT**

Sgt. Oliver Albert of the Hamilton County Sheriff's office reported that there were very few incidents in Harrison Township. There were no criminal cases and nine non-criminal cases for the month of September. There was a total of 11 auto crashes. There were 177 calls for service in Harrison Township during this period. Deputies responded to 99 of those calls for service and logged out 78 calls for service due to Be On the Look Of, public services, EMS etc. The average response time to responded calls for service was 11 minutes, which is the same last month.

### **FIRE REPORT**

Mr. Louis reported he attended a fire meeting and the Township had 6 incidents for fire and EMS. The department had 68 calls for service and calls are 20% higher this year compared to last year.

**ZONING REPORT**

Mr. Dole reported he has received many calls on the condition for a property located on Carolina Trace. The County departments are working on the condition of the property and the Health Department has given an extension for the septic system.

Mr. Louis made a motion to approve a resolution accepting the amounts and rates as determined by the budget commission & authorizing the necessary tax levies and certifying them to the county auditor. Mr. Dole seconded the motion, roll call-all yea.
