#### POLICE REPORT

Sgt. Oliver Albert of the Hamilton County Sheriff's office reported that there were several incidents in Harrison Township. There was 1 theft report and 2 assaults for the month of June. There was a total of 6 auto crashes. There were 136 calls for service in Harrison Township during this period. Deputies responded to 85 of those calls for service and logged out 51 calls for service due to Be on the Look Of, public services, EMS etc. The average response time to responded calls for service was 7 minutes, which is down 8 minutes from last month.

After discussion Mr. Dole made a motion to conclude the public hearing Mr. Louis seconded the motion, roll call – all yea.

#### **BUSINESS REPORT**

Mr. Louis made a motion to approve the FY 2024 Annual Tax Budget to be submitted to the Hamilton County Auditor. Mr. Dole seconded the motion, roll call - -all yea.

A Resolution Adopting Regulations Prohibiting Excessive Noise and Ordering Notice was presented to the Board of Trustees for consideration. After a lengthy discussion over different sections of the resolution Mr. Dole made a motion Adopting Regulations Prohibiting Excessive Noise and Ordering Notice with the following changes:

Page 4 Section 2 A (i) for passenger cars the dBA levels be changed from 70 to 82. Section 2 A (ii) for passenger cars the dBA levels be changed from 79 to 86.

Page 4 Section 4 Prima Facie Evidence and Determination of Violation amplified noise in excess during nighttime be change from 55 dBA to 60 dBA.

Mr. Louis seconded the motion, roll call Mr. Dole – Yea Mr. Louis – Yea Mr. Losekamp Nay. Motion Passed.

#### **CORRESPONDENCE**

Mr. Losekamp received a preliminary drawing and estimate for the I-74 & Dry Fork Overpass from the Engineering group developing the project. The estimated cost of the project is in excess of 3 million dollars.

Mr. Losekamp attended a meeting with HCDC and reported that they will continue the tax abatement program in Hamilton County.
