MINUTES OF HARRISON TOWNSHIP BOARD TRUSTEES REGULAR MEETING

OPENING

The Harrison Township Board of Trustees met in regular session with Chairman, Thomas C. Losekamp, calling the meeting to order. Answering the roll call were: Frederick A. Dole and Thomas C. Losekamp and Mark A. Louis.

APPROVAL OF MINUTES

Mr. Dole made a motion to approve the minutes of the April 19, 2023 regular meeting. Mr. Louis seconded the motion, roll call – all yea.

FISCAL OFFICER'S REPORT

Mr. Louis made a motion to approve the Fiscal Officer's Financial Report, which includes the payment of the bills. Mr. Dole seconded the motion, roll call – all yea.

VISITORS

Caitlin Snyder from the Public Library spoke to the Board and gave a report on various activities and resources available this year at the Harrison Branch Library.

POLICE REPORT

Sgt. Oliver Albert of the Hamilton County Sheriff's office reported that there were several incidents in Harrison Township. There was a series of vehicle thefts at Circling Hills Golf Course. Identity fraud, Criminal Damaging and residential thefts for the month of April. There was a total of 6 auto crashes. There were 130 calls for service in Harrison Township during this period. Deputies responded to 74 of those calls for service and logged out 56 calls for service due to Be on the Look Of, public services, EMS etc. The average response time to responded calls for service was 15 minutes, which is up 3 minutes from last month.

FIRE REPORT

Mr. Louis reported that fire department responded to 10 fire and 49 EMS runs for the month of April. The Fire Chief detailed plans to start a new program to address drug abuse.

Township legal counsel is in the process to develop a resolution addressing non-compliant properties who are considered a nuisance.

BUSINESS REPORT

Mr. Louis made a motion to approve Resolution # 051723A approving the update of the Solid Waste Management Plan of the Hamilton County Solid Waste Management District Mr. Dole seconded the motion, roll call – all yea.

Mr. Losekamp reported that after reviewing the bids for the Deer Trace Road resurfacing project Rock and Ballauer has been awarded the project with a bid of \$68,725.00.


ADJOURNMENT
