POLICE REPORT

Sgt. Oliver Albert of the Hamilton County Sheriff's office reported that there were several incidents in Harrison Township. There were 2 Theft reports, Criminal Trespassing, Disorderly Conduct and a Burglary for the month of August. There was a total of 8 auto crashes. There were 152 calls for service in Harrison Township during this period. Deputies responded to 100 of those calls for service and logged out 52 calls for service due to Be on the Look Of, public services, EMS etc. The average response time to responded calls for service was 12 minutes, which is up 2 minutes from last month.

BUSINESS REPORT

Mr. Losekamp made a motion to approve a Resolution requesting transfer of a portion of Howard Road from Hamilton County to Harrison Township of the Board of Trustees for Harrison Township, Hamilton County, Ohio. Mr. Dole seconded the motion, roll call – all yea.

Mr. Losekamp met with the Harrison Recreation Commission and distributed information on a proposed splash pad. The project may cost between 208K to 500K. After some discussion it was decided that many variables need to be worked out before any decision can be made.

The Senior Center is looking for a 20passenger van to transport seniors to events. More information will be available after details and feasibility have been explored.

Mr. Losekamp was contacted by the Hamilton County Administrator and Sheriff's office to possibly meet with Crosby, Whitewater and Harrison Townships at the Harrison Township Civic Center to discuss patrol services. So far little interest has been received from the other Townships. More information will be forthcoming.
