CALL TO ORDER

The Harrison Township Board of Trustees met in regular session with Chairman, Thomas C. Losekamp, presiding. Present were: Kenneth W. Fohl, Larry E. Kinnett and Thomas C. Losekamp.

APPROVAL OF MINUTES

Mr. Kinnett made a motion to approve the minutes of the April 17, 2024 regular meeting. Mr. Fohl seconded the motion. **Roll call – all yea**

FISCAL OFFICER'S REPORT

Mr. Kinnett made a motion to approve the Fiscal Officer's Financial Report, which includes the payment of the bills. Seconded by Mr. Fohl. Roll call – all yea

VISITORS

Nancy Whitney thanked the Board for Their help in resolving some of her issues on Harrison Avenue. She gave Mr. Fohl information about a nuisance property next to her home.

Melissa Heidtmann with the Harrison Branch of the Library gave information on their upcoming events.

Hickory Woods resident Joe Forbeck asked the Board to look into an issue he is having with his neighbor located on Lees Creek Road shooting firearms. He asked about Noise Resolutions and the possibility of a gun fire ordinance. Corporal Schaefer responded that if it is during the hours of 7am to 10pm there isn't anything the police can do. Mr. Losekamp will check with the Township attorney to see if there is any other legal way to stop the noise.

POLICE REPORT

Corporal Schaefer of the Hamilton County Sheriff's office reported on the prior month's police incidents in Harrison Township. Of note there was 1 criminal damaging report and 1 theft report. There was a total of 3 auto crashes. There were 123 calls for service in Harrison Township during this period. Deputies responded to 66 of those calls for service and logged out 57 calls for service due to Be on the Look Of, public services, EMS runs etc. The average response time to responded calls for service was 6 minutes, which is the same as last month.

FIRE REPORT

Mr. Kinnett reported that Engine 57 (Township owned) is due for routine maintenance.

Mr. Fohl is going to contact the County to see what action has been taken with the property at 11440 Carolina Trace.

BUSINESS REPORT

The Board discussed the City's request to replace the security system at the Community Center. Mr. Losekamp had several questions, and more bids were needed before the Board decides on the Township's amount of money given toward the purchase.

The Fiscal Officer explained the City's reasoning regarding annual payments from the JEDD. Mr. Losekamp would like to meet with the Finance Director to go over this information.

Mr. Losekamp attended a meeting for the Dry Fork Road overpass. More turn lanes are being added and the cost is increasing. The project is slated to begin in 2026, TRAC and SKIP funds are being pursued. He is not sure how much the Township can contribute, especially with the rising cost.
