## **MINUTES OF HARRISON TOWNSHIP BOARD OF TRUSTEES REGULAR MEETING**

### **CALL TO ORDER**

The Harrison Township Board of Trustees met in regular session with Chairman, Thomas C. Losekamp, presiding. Present were: Kenneth W. Fohl, Larry E. Kinnett and Thomas C. Losekamp.

### **APPROVAL OF MINUTES**

Mr. Kinnett made a motion to approve the minutes of the June 18, 2025 regular meeting and the June 30, 2025 special meeting. Mr. Fohl seconded the motion. **Roll call – all yea**

### **FISCAL OFFICER'S REPORT**

Mr. Kinnett made a motion to approve the Fiscal Officer's Financial Report, which includes the payment of bills including electronic payments. Seconded by Mr. Fohl. **Roll call – all yea**

### **POLICE REPORT**

Lt. McElroy of the Hamilton County Sheriff's office reported on the prior month's police incidents in Harrison Township. Of note there was a water rescue. There was a total of 5 auto crashes. There were 148 calls for service in Harrison Township during this period. Deputies responded to 120 of those calls for service and logged out 28 calls for service due to Be on the Look Of, public services, EMS runs etc. The average response time to responded calls for service was 11 minutes.

### **PUBLIC HEARING**

The Board entered into a Public Hearing for the purpose of discussing the FY 2026 Annual Tax Budget at 8:54pm. After a brief discussion the Board went back to the Regular Meeting.

### **TRUSTEE REPORTS and CORRESPONDENCE**

Mr. Losekamp reported the City wants to install an electronic gate at the Etta Avenue Community Center entrance. The City also has a \$90,000 grant to install a new reader board welcome sign. They will move and replace the one on Harrison Avenue and hopefully the one on George Street. We may be asked to split various costs for these items. He also reported Hilltop Performance will have an open house on July 27<sup>th</sup> at their location.
